

# Orpington 1<sup>st</sup> Recycling scheme

A comprehensive recycling scheme will be introduced over the coming months with collections eventually made at source, but as an interim measure and at no cost to individual businesses BID levy payers can bring their cardboard and plastic/polythene recycling to the Walnuts for compacting from Monday 1<sup>st</sup> April 2013.

Cages will be available at the bottom of the slip road just before the Walnuts Car Park for cardboard and plastics.

## What are the next steps?

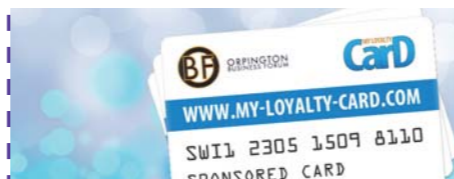
**There is much work to be done by the Members of the Board, supported on a temporary basis by the Town Centre Manager and others, to get the BID ready for operation.**

The BID will build on the existing partnership between the council and local businesses to develop projects and services defined by the traders. Key issues to be handled by Orpington 1<sup>st</sup> over the next five years include improving the look and feel of the town, promoting it as a destination for shoppers and potential

investors, improving accessibility and parking, tackling crime and anti-social behaviour and introducing initiatives to reduce costs to businesses. # Success for Orpington 1<sup>st</sup>

Businesses have approved the exciting initiative to boost Orpington town centre at the ballot in February. The establishment of the Orpington 1<sup>st</sup> BID will give them real power on the management of their town centre. The BID Company will use the levy money along with funds generated from other sources to deliver additional services to boost the town centre and its businesses.

The total number of votes cast in the ballot was 164, representing a turnout of 48%. 54% voted in favour, representing 60% of the rateable value.

## Timetable

- The legal entity Orpington 1<sup>st</sup> established from 1<sup>st</sup> April.
- Theme groups will be established to develop projects based on the BID proposal.
- BID levy bills are expected to be delivered during June. The BID levy income will therefore not be available to spend until July.
- All BID levy payers will receive a letter inviting them to become members of the company in June, this will enable them to vote at the AGM.
- The AGM will be held on 11<sup>th</sup> September 6pm Bromley College, Orpington Campus.



### Welcome from the BID Chairman

Orpington 1<sup>st</sup> Ltd will be a non-profit company owned and funded by the businesses within a defined area of the town – primarily the High Street.

Bromley College have donated office space at the Orpington campus (1<sup>st</sup> Floor, Bromley Online Centre) and ancillary services to include fiscal advice and monitoring, this will be of great benefit to the BID company who are very conscious of keeping down operating costs.

We will be writing to all businesses within the BID area to invite them to become a BID Company Member, and any member can stand as a Board Member and Director of the BID Company. At present the BID Company has six interim Board Members – but we are looking for more local business owners and managers to get involved, to help shape the development of the company until the election of the Board at our first Annual General Meeting. I am very proud to be stepping into the role of BID Board Chairman to oversee the early stages of the BID's development. I look forward to working with you to make the town better for business.
